- Women harassment (Internal Complaints Committee-ICC)

The grievance committee members investigate the cases through following mechanism:

- An individual has to submit a grievance form
- The submitted form is reported to the IQAC.
- The IQAC then review the grievance and forward to Principal Office.
- The concerned section will then takes action and submit the report to the grievance committee for the closure of grievance within stipulated time.
- The information about the action taken is communicated to the individual who has put up the grievance.






